

PICCELL WIRELESS PHONE REBATE TERMS AND CONDITIONS

*** The client must meet the following minimum requirement of usage:**

The total amount of the client's usage on the primary SIM associated with the Rebate World Phone must exceed \$60 US. This excludes all usage associated with a US Virtual Number contract or any additional SIMS that may have been rented.

* Return the rental SIM (and all other property of PicCell Wireless and/or its affiliates) within 10 days of the end of the service agreement through use of the official return service label and rebate form. The return service label and rebate form are available online through the client's 'My PicCell' account. (If the client attempts to return the rental items without using the official return service label, they are responsible for replacement if lost in transit and any fraudulent traffic as outlined in the Terms and Conditions).

To qualify for the rebate, a rebate form must be enclosed and returned to PicCell with the rental SIM, except for clients whose contracts were signed before October 20, 2008.

* Replacement phones and chargers may be available in cases of broken equipment due to proper use. In cases where replacement equipment has been provided, the client is required to return the faulty equipment. PicCell reserves the right to deny the rebate if the phone/charger is determined to have been broken due to improper use.

* In the event that termination of the service agreement occurs before the end of the billing cycle documenting the client's eligibility for the rebate, a delay in crediting the client's credit or bank card may occur. Allow up to 90 days for the rebate to post. At which time the client is encouraged write PicCell at info@piccellwireless.com after that point if the rebate transaction has not yet occurred. The client is required to keep a current and active credit or bank card on file with PicCell Wireless.
